का.नि.आ. 70.— राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, रक्षा अनुसंधान और विकास संगठन तकनीकी काडर भर्ती नियम, 2000 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :

S. R. O. 70 .— In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Defence Research and Development Organisation Technical Cadre Recruitment Rules, in 2000 namely :—

1. (1) These rules may be called the Defence Research and Development Organisation Technical Cadre Recruitment (Second Amendment) Rules, 2014.

(2) They shall come into force on the date of their publication in the Official Gazetted.

2. In the Defence Research and Development Organisation Technical Cadre Recruitment Rules, 2000 in Foot Note, in Note 4, for the words and letter "Technical Assistant 'A'", the words and letter "Technical Officer 'A'", shall be substituted.
