

You may contact The Director, Scientific Analysis Group (SAG), Metcalfe House, Civil Lines Delhi-110054 for any grievance related to the condition, process and/or rejection of response to this EOI, with regard to process & conditions, this shall be done at least ten days in advance of the stipulated date of submission.

The subsequent tender/RFP, if floated, will be subjected to formal General and Specific terms and conditions of the tendering process and requirement of government procurement.
9. A 100% subsidiary would be required to produce documentary evidence in support of their claim along with their responses, failing which their response would be disqualified.
10. **Clarification regarding contents of the responses to Eoi:** During evaluation of responses to this Eoi, the SAG may, at its discretion ask the respondent for clarification. The request for clarification will be given in writing/through email. No clarification on the initiative of the respondent will be entertained after submission date.
